Profile: Dave Roeder

When Dave Roeder graduated from Ranken Technical College in 1964 from Tool and Die Design, he never expected to travel the world as part of his job. However, his education and career led him to Sunnen Products where he worked as a Manufacturing Engineer. His experience and technical training eventually helped him to obtain a position in international sales where he was one of only two people in the company devoted to overseas sales. Dave traveled extensively in Asia, Europe and South America and he really enjoyed this aspect of his job.

"I never anticipated getting into sales let alone traveling overseas as part of my career," Dave said, "but Sunnen needed someone with a technical background and I was more than happy to help out." Being born and raised in St. Louis, Dave expected that his job and career would be focused here in St. Louis. "You just never know where your education and training will lead which is one of the reasons why I feel so good about graduating from Ranken. It provided me with a great foundation for my career."

They spoke with their financial advisor and determined that this was something they could do. They do not have any children which is one of the reasons they were comfortable leaving something to Ranken in their Will. They have several organizations that they actively support so they decided the easiest thing to do was to leave a percentage of their estate to the College as a bequest.

"We were both fortunate to have good jobs and to be able to accumulate some

assets during our careers. I realize that my education was how I got started. It was the building block for my career, so I wanted to give something back to the school in order to give others the same chance that I had."

Dave's advice to other Ranken graduates: "Consider the impact that Ranken has had on your life, and ask yourself if you can help others to achieve the same thing. You don't have to give away millions to make a planned gift. Whatever you can afford to do is what really matters - there is no minimum." Dave and Judy feel that Ranken represents the type of institution that can make the best use of their support.

Dave retired from Sunnen in 2002. His wife, Judy, is also retired after working as an Administrative Assistant for many years for Massachusetts Mutual. They spend their free time pursuing their interests, volunteering and working around the house. And come April each year, you are likely to find Dave at the Ranken Car Show and Alumni Reunion.
